Friday 10th May: Day time: commence 11am to 9pm, all area security (includes Showground perimeter fence line) + gates, 4 Guards.
Gate 5: 6am to 9pm 1 Guard

Nighttime: commence 8pm to 6am 11th May. All area Security, 4 Guards.

Nighttime: commence 5pm to 11.30pm, Bar Area, 4 Guards; also, Side Show area, 2 Guards.

Stock Pavilions (Cattle, Sheep, Prime Lambs, Horses) to be checked during the nighttime patrol.

Saturday 11th May:

Day time: commence 10am to 9pm – all area security (includes Showground perimeter fence line) + gates, 6 Guards.
